- College or Trade School correspondence confirming matriculating for 2022 - 2023. (College or Trade Applicant)
- Complete a well written, grammatically correct essay of 300-500 words. **The essay must be applicable to two (2) of the four (4) questions listed on the application.**

The deadline for submission of the application is **Wednesday, May 31, 2023**. The winner will be notified by **Wednesday, June 14, 2023** and will be awarded the winnings on **Sunday, July 2, 2023**.
