## Student Pledge for the Use of District-Owned Personal Mobile Computing Device

- 1. I will take proper care of the personal mobile computing device and be accountable for the device at all times.
- 2. I will not lend the personal mobile computing device, charger and keyboard to others.
- 3. I will charge the battery of the personal mobile computing device daily.
- 4. I will keep food and beverages away from the personal mobile computing device.
- 5. I will not disassemble any part of the personal mobile computing device, nor attempt repairs.
- 6. I will not remove or delete district required applications, profiles or restrictions and will not attempt to access or alter other accounts or devices.
- 7. I will protect the personal mobile computing device by carrying it in the case provided.
- 8. I will save data in a safe accessible location. Students are ultimately responsible for saving their personal files.
- 9. I will not place decorations (such as stickers, markings, etc.) on the personal mobile computing device or district issued protective case.
- 10. I will not deface the serial number, manufacturer's labels or district labels on any personal mobile computing device.
- 11. I will follow district policies outlined in the district's Acceptable Use Policy.
- 12. I will notify my teacher or administrator immediately if the device has been lost, stolen or vandalized.
- 13. I will be responsible for all damage or loss caused by neglect or abuse.
- 14. I agree to return the personal mobile computing device, keyboard, case and power cords in good working order at the end of the school year, if I transfer schools, or leave the district for any reason. If you return to PTHS, the same tablet will be issued to you next year.

## When using network or internet resources, I will:

- 1. Use the internet for legitimate educational purposes
- 2. Send e-mail only at the direction of my teacher during school hours
- 3. Not attempt to download or save files to the device without teacher permission
- 4. Not search for, download or print any material that violates school handbook codes regarding possession or display of inappropriate or vulgar material, or assist any other student in such activities
- 5. Not harass, insult, or attack others via electronic communications
- 6. Not damage or alter computers, computer systems, computer networks or mobile devices
- 7. Not violate copyright laws
- 8. Not trespass in another's folders, work, files or devices

I understand that my participation in any violation of these items above will result in disciplinary action set forth in the student handbook including possible loss of access privileges to such resources.

The New Jersey Anti-Big Brother Act, which went into effect on July 1, 2013 states that the district will provide the pupil and parent with written or electronic notification that the technology device provided by the school may record or collect information on the pupils activities or the pupil's use of the technology device if the device is equipped with a camera, global positioning system, or other feature capable of recording or collecting information on the pupil's activity or use of the device. Pemberton Township School District shall not use any of these capabilities in a manner that would violate the privacy rights of the pupil or any individual residing with the pupil.
