Proposals must be submitted in sealed packages. The sealed packages shall be delivered between the hours of 9:00 a.m. and 3:00 p.m., Monday through Friday, to the Office of the School Business Administrator, Brotherhood Administration Building, 1 Egbert Street, Pemberton, NJ 08068. The sealed packages shall bear the name and address of the proposer and shall be marked "**ENGLISH LANGUAGE ARTS (ELA) CONSULTANT**". The original and three copies of each proposal should be submitted. All proposals **MUST** be submitted and time-stamped by the Office of the Business Administrator no later than the date and time designated for opening. The Pemberton Township School District will not be liable for any proposals lost in the mail or misdirected by any party.
